For the quarter ended 30 September 2024, the Group maintained a good operational performance with an increase in revenue from Rs 826m to Rs 956m compared to the same period last year. The continuous efforts in implementing efficiency measures have helped mitigating the impact of inflation and increasing operational and staff costs. Profit after tax was also impacted by escalated depreciation and financing expenses related to the Group's major capital investment, especially the new Cancer Unit, the new clinic in Grand-Baie and infrastructure and technological upgrades.
